- 1. Bonnie Cameron, Troy Theodore and Bill Veenstra were endorsed as candidates for BC Hockey Lower Mainland District Director for the 2014-2015 season.
- 2. BC Hockey Championships March, 2015:
  - (a) Semiahmoo MHA was approved as the Lower Mainland's choice to host the 2015 BC Hockey Peewee Tier 1 Championship.
  - (b) No applications to host the Bantam Tier 4 championship had been received. BC Hockey will allocate this Championship to another District if no Association comes forward.
- 4. Financial matters:
  - (a) The PCAHA audited financial statements for 2013-2014 were approved.
  - (b) The PCAHA operating budget for 2014-2015 was approved.
  - (c) Smythe Ratcliffe LLP was re-appointed as Auditor.
- 5. Members of the 2014-2015 PCAHA Executive Committee were elected or ratified. A complete Executive Committee list including duties and appointments will be circulated in early August.
- 6. At lunch time at the AGM the recipients of the PCAHA Special Awards for 2013-2014 were recognized.
